The World Bank is also financing the Second Generation Power Sector Reforms of the Dominican Republic Power Sector Program through US\$150 million of financing in the period 2005-2008.

How many distribution companies are there in the Dominican Republic?

In the Dominican Republic, there are three distribution companies. The government owns two of them, EdeNorte and EdeSur, through the CDEEE (50%) and the Fondo Patrimonial de las Empresas (FONPER).

The new SIBA Energy natural gas-fired power plant in the Dominican Republic features 12 Titan model turbines. It will have 280 MW of generation capacity when operating in combined cycle configuration.
