Will Candu Energy be a hybrid?

CBC News spoke to four employees at Candu Energy Inc., located in Mississauga, Ont., who confirmed they received the notice through an internal memo last Thursday afternoon. They say they were previously told that likely wouldn't happen until September, and even then, it would be under a hybrid model.

Why did SNC-Lavalin give a short notice to Candu Energy employees?

In a statement to CBC News, SNC-Lavalin confirmed the notice was issued to employees of Candu Energy Inc. on Thursday, effective Monday, but didn't respond to questions about why such short notice was given. The company said due to the nature of the work, "hundreds" of employees have continued to work in-person through the pandemic.

Is Candu Energy a retaliatory move against the Union?
