Who is Livent & allkem?

Livent is a global leader in lithium processing technologies with nearly eight decades of experience producing a diverse range of lithium chemicals for energy storage and other specialty applications. Allkem brings complementary expertise in conventional brine-based lithium extraction, hard rock mining, and lithium processing.

How did Livent Corporation perform in Q4 2022?

Livent Corporation (NYSE: LTHM) reported fourth quarter revenue of \$219.4 million, which was down 5% compared to the third quarter of 2022 and up 79% compared to the prior year's quarter. Livent Corporation today reported results for the fourth quarter and full year of 2022.

Does Livent sell lithium hydroxide outside of Argentina?

Livent sells lithium hydroxide outside of Argentina and is currently qualifying product with customers at its new 5,000 metric ton lithium hydroxide line in Bessemer City. Commercial volumes will be delivered in 2023. Livent remains the largest producer of lithium hydroxide in the United States with a combined 15,000 metric tons in domestic capacity.

Where are Livent & allkem based?

Additionally, Livent has a mining and refining operation under development in Quebec, Canada (the Nemaska Lithium project). Allkem is primarily a raw lithium miner, with projects cranking out the chemical in Argentina and Western Australia, a new project in development in Quebec, and a small refinery wrapping up construction in Japan.

Allkem's Chief Executive Officer, Martin Perez de Solay, said: "The combination of Allkem and Livent is transformational with compelling strategic logic and marks a significant milestone in our efforts to grow the company."
