Who makes Nordex wind turbines?

Since the merger with Acciona Windpower in 2016, the Nordex Group has become a global player and one of the world's largest wind turbine manufacturers. The Group offers highly efficient and competitive wind turbine systems, which enable long-term economical power generation from wind energy in all geographical and climatic conditions.

The Nordex Group is one of the world's leading OEM's with 35 years of experience in manufacturing highly efficient wind turbines for global onshore markets.

What is a Nordex gamma wind turbine?

As of 2013, the third generation of Nordex wind turbines included two platforms, rated at 2.4 and 3.3 MW. In Europe, Africa and North America Nordex manufactures and sells the Gamma series, a product family comprising the N90/2500, the N100/2500 and the N117/2400. The N90/2500 is a turbine being developed for strong winds.

Does Nordex own Acciona Windpower?

Nordex has completed the acquisition of Acciona Windpower (AWP) from Spain's Acciona for EUR785m (\$880m), after receiving approval from the competition authorities. The wind power market has grown at a CAGR of 14% between 2010 and 2021 to reach 830 GW by end of 2021.

Where is Nordex located?

The company has offices and branches in more than 30 countries. The holding company, Nordex SE, is listed on the TecDAX and MDAX of the Frankfurt Stock Exchange (ISIN: DE000A0D6554). The headquarter of the company, with the Management Board and central corporate functions, is located in Hamburg, while the legal entity is registered in Rostock.

Nordex confirmed the incident and said its experts were investigating the root cause of the incident. The damaged turbine had been maintained regularly, Nordex added. The OEM last month had suffered the collapse of a turbine from its N149 model at a wind farm in western Germany for yet unknown reasons in what appears to be an unrelated event.
