

Is a 50MW project a key market for energy storage in Poland?

The acquisition of two 50MW projects totalling 400MWh of capacity marks the developer's first entry into Poland, which is fast becoming a key market for energy storage in the Central and Eastern Europe region.

Will Poland lead Eastern Europe's battery storage market?

Poland is set to lead Eastern Europe's battery storage market, with 9GW offered grid connections and 16GW in the capacity auctions.

Who issued the first electricity storage license promise in Poland?

The promise was issued by the President of the Energy Regulatory Office. PGE Group is working on the largest energy storage facility in Europe. The project obtained the first license promise in Poland for electricity storage.

Will PGE build Europe's largest energy storage facility?

PGE Group is set to construct Europe's largest energy storage facility, with a capacity of up to 263 MW and a minimum of 900 MWh, near the Żarnowiec Pumped-Storage Power Plant. The project, expected to be tendered in mid-2024, aims to support the balancing of PGE's land and offshore wind farms on the Baltic Sea.

How does a capacity market unit work in Poland?

The functioning of a unit in the capacity market in Poland can be generally divided into three main stages--certification of the supplier and its capacity market unit, subsequent (main and supplementary) auction rounds and performance of the capacity obligation. BESS were awarded for the first time in a 2022 auction.

As energy storage systems become less expensive and competition grows, trading strategies gain in complexity. Until recently, energy storage systems in Europe relied on "traditional" revenues that were mostly reliant on frequency control services such as the Frequency Containment Reserve (FCR) in countries like France or Germany.
