In Jamaica, the consumer gets a Customer Interphase Unit resembling a security alarm keypad, which the power company installs in the home. The unit beeps when only five kilowatt-hours remain. If the consumer cannot top up before the credit expires, they can call the power company for an additional five kilowatt-hours.

Developed by Shams Power Company, a joint venture between Masdar, Total and Spain's Abengoa Solar, the \$600m plant will power 20,000 homes in the UAE and displace 175,000 tonnes of CO2 per year. The CSP plant also features a dry-cooling system that reduces the consumption of water, a critical benefit in the arid desert.
