What file format do I need for a solar PV plant?

Annex F and Annex C "Documentation set accompanying the solar PV plant" of the O&M Best Practice Guidelines. It is important to underline the file format that must be used. All the technical drawings should be received both as a PDFwith stamp and signature and as an editable format (.dwg).

#### Who are the solar PV contributors?

The contributors work across the solar PV industry and they include EPC and O&M service providers, Asset Managers, Asset Owners, renewable energy consultants, legal experts, digital solutions providers, technical advisors, and investors.

Are solar farms covered by a national policy statement?

Although solar farms are not covered in the existing suite of National Policy Statements, the draft National Policy Statement for renewable energy infrastructure covers solar farms at the scale of nationally significant infrastructure. The draft National Policy Statements are currently undergoing Parliamentary scrutiny.

#### Do solar PV farms need planning permissions?

Solar PV farms should normally be regarded as a temporary use of land. It is therefore likely that planning permissions will limit the duration for which the system can remain in place. Planning permissions will normally; Be for a temporary period only from the commissioning of the facility.

#### Do you need a permit for a solar PV power plant?

Permitting and licensing requirements for solar PV power plants differ significantly from country to country and even, within different country regions. All necessary environmental permits, licenses and requirements must be acquired prior to start of construction. It is a common practice to hire obligations relevant to the venture.

What guidance does the Civil Aviation Authority (CAA) provide regarding solar energy?
