What is a capital subsidy scheme for solar power plant?

Under the scheme, capital subsidy will be provided to the eligible industries on capital investment for setting up of Solar Power Plant for generation of power. The scheme encourages MSMEs to use Solar Power through this assistance. 25% subsidy subject to a limit of maximum of INR50,00,000/-.

What is solar subsidy scheme in India?

Under the scheme,households will be provided with a subsidy to install solar panels on their roofs. The subsidy will cover up to 40% of the cost of the solar panels. The scheme is expected to benefit 1 crore households across India. It is estimated that the scheme will save the government Rs. 75,000 crore per year in electricity costs.

What is Modi's solar subsidy scheme?

The scheme was launched by Prime Minister Narendra Modi on February 15, 2024. Under the scheme, households will be provided with a subsidy to install solar panels on their roofs. The subsidy will cover up to 40% of the cost of the solar panels. The scheme is expected to benefit 1 crore households across India.

How much subsidy is given for solar pump installation?
