Who owns Axion Energy?

AXION energy is created: Bidas Corp. acquires the fuel refinery and sale assets from ExxonMobil (Esso) in Argentina, Uruguay and Paraguay. Pan American Energy successfully completes placing its negotiable instruments for USD 500 million. Chinese state-owned CNOOC Limited acquires 50% of Bidas Energy Holdings Ltd.

Who owns PAEG & Axion?

PAEG will be owned equally by BP and Bidas Corporation, itself a 50:50 joint venture of Bidas Energy Holdings of Argentina and CNOOC Limited of China. PAE is currently owned 60% by BP and 40% by Bidas, while Axion is wholly-owned by Bidas. There will be no payments for the equity exchange.

Is Axion a sustainable company?

Axi&#243;n is a national wholesale operator of telecommunication infrastructures and services. As part of Axi&#243;n's solid commitment to the development of ESG policies, its headquarters in Valencina de la Concepci&#243;n (Seville) has obtained the prestigious BREEAM certification in Sustainable Infrastructures.

What is the strategic alliance between Axion Energy and Castrol?

Strategic alliance in Argentina between AXION energy and Castrol. With this agreement, the refinery in Campana produces 90% of the Castrol product line, and more than 400 products are distributed and commercialized through our service station network.

Who owns Pan American Energy Group?

The new company, Pan American Energy Group (PAEG), will be the largest privately-owned integrated energy company operating in Argentina. PAEG will be owned equally by BP and Bidas Corporation, itself a 50:50 joint venture of Bidas Energy Holdings of Argentina and CNOOC Limited of China.

How does Pan American energy finance its investments in Argentina?

Pan American Energy obtains a USD 200 million loan to finance its investments in Argentina. The International Finance Corporation (IFC), a World Bank entity that provides financing to the private sector, grants the company a USD 500 million loan for our operations. This was the largest loan granted by the institution in 51 years.
